### How to make a tax free gift from your IRA to Case Western Reserve University

The IRA charitable rollover, also known as a Qualified Charitable Distribution (QCD), is a powerful way to support Case Western Reserve University while also enjoying tax benefits. If you're age 70½ or older, you can make a tax-free gift directly from your IRA to CWRU regardless of whether or not you itemize deductions. (An annual withdrawal becomes mandatory at age 73.) For donors age 73 or older who must take annual RMDs, a QCD can also fulfill your Required Minimum Distribution (RMD) without raising your taxable income. And whether or not you itemize your deductions, a QCD may reduce your overall tax burden.

### How do I qualify?

- You must be age  $70\frac{1}{2}$  or older at the time of the gift.
- Gifts must be made directly from your IRA to Case Western Reserve University. No personal withdrawals or transfers will count.
- Eligible accounts include Traditional IRAs and inactive SIMPLE or SEP IRAs; Roth IRAs may also qualify depending on your particular circumstances.
- The QCD cap is adjusted annually for inflation—in 2025, eligible donors can give up to \$108,000 tax-free. Always ask your financial advisor for current limits.

### Benefits of a QCD

- QCDs are excluded from your gross income, providing a strategic way to minimize taxes, even if you don't itemize.
- Satisfy your RMD while reducing your taxable income.
- Direct your gift to any school, program or area at CWRU that reflects your values.
- Create an immediate impact with your gift.

#### How to Make a QCD

- Contact your IRA administrator for their QCD distribution form or information on their QCD procedures.
- If you have IRA check-writing privileges, you may send a check made payable to Case Western Reserve University directly to: Office of Advancement Services, Case Western Reserve University, 10900 Euclid Ave, Cleveland, OH 44106-7035
- Consult your tax advisor to confirm eligibility and proper reporting to ensure the gift meets IRS guidelines.
- CWRU will provide written acknowledgment for your records and tax reporting.

- IRA assets typically pass outside of probate, simplifying estate administration.
- It may reduce the tax burden on your heirs, as retirement assets are typically taxable to non-charitable beneficiaries.

### How to name CWRU as a beneficiary

- Contact your IRA administrator or log into your account.
- Designate Case Western Reserve University as a full or partial beneficiary.
- Use the following information:
